There is requirement of making food arrangements for about 1400 participants including students/teachers/volunteers for 5 days. The details of date wise food requirement, menu specifications & other activities to be done are available in the website of ST & SC Development Department/ ATLC www.stscodisha.gov.in/ www.atlcodisha.org from **1st September, 2017 to 20th September, 2017**. Interested Caterers / Food Suppliers may offer their price per head per day in Sealed Quotations for supply of quality and delicious foods and to do all other related activities and submit their quotations in the Office of the ATLC on or before **21st September, 2017 by 2.00 P.M.** The interested agencies shall have to submit their sealed quotations along with a non-refundable Bank Draft of Rs.1, 000/- towards quotation value and a D.D. of Rs.20, 000/- towards EMD drawn in any Nationalized Bank in favour of Member Secretary, ATLC, Bhubaneswar. Besides, the Agency shall have to submit copy of valid GST Registration Certificate with up to date Challan deposit copy, valid food preparation licenses from concerned authority, Trade License from BMC and copy of experience certificates/ work order conforming execution of similar activities for supply of foods other than Sargiful specially for children not less than Rs. 5,00,000/- as a single order, minimum turnover of Rs. 10,00,000/- (per year) for last three conjunctive years duly certified by C.A. along with the quotation. The Quotations will be opened on **22nd September, 2017 at 4.30 PM**. The authorized representative(s) of the agency may remain present at the time of opening of the quotations. The EMD of the unsuccessful agencies will be refunded within a week. After finalization of the quotations where the L-1 bidder will be declared as eligible to be awarded with the tender.
